

More great things to come for Duke Heights in 2020

The new year is here and exciting new developments are taking place all throughout York Centre and Duke Heights.

Dear neighbours,

Improvements to accessibility is one of the key focuses of the coming year, and my office will continue to make sure that local street lighting, sidewalk connectivity, cycling infrastructure and other city assets are there to help workers and residents get to and from work safely.

Improvements to the pedestrian realm will be made with the proposed reconstruction of sidewalks on Chesswood, Alness and Flint. As well, I am pleased to announce that BikeShareTO, the city's bike share program, will be launching a pilot project along the Finch hydro corridor, with bike stations located along the path. Users will be able to pick-up and drop-off bikes at various stations along the corridor to enjoy surrounding green spaces, and we will be working on adding additional stations at Downsview Park and York University. Green spaces are important for any community to be healthy and livable, and the Duke Heights BIA has championed the cause of transforming city owned land into green space with a proposal to establish a parkette at the Dufferin Transfer Station, creating a valuable



social node. We are also beautifying the east side of Dufferin Street with investments in public realm projects, art work, seating and vegetation.

Adding to services available, I am pleased to announce that the North York Outpatient Hospital will be opening at the Champagne Centre, and we are excited to be breaking

ground on a new fire station on Keele Street just south of Sheppard Avenue West that will service much of the Duke Heights community. The Toronto Public Library's Downsview branch is open after much needed renovations, and we are pleased with the preliminary designs of the new Centennial library. 

City Council Update:

At City Council's meeting on February 19, I presented two motions, both of which passed. One extended library hours across 8 library branches. The purpose of the extension is to allow for the full operation of Youth Hubs at these locations. This will result in adding 5,538 hours annually to the Centennial, Downsview, Flemington Park, Jane/Dundas, Kennedy/Eglinton, Mount Dennis, Sanderson and Weston branches. This will allow these libraries to stay open longer during the evenings as well as on weekends, making them more accessible for youth and all users.

The second motion requested a report back from Revenue Services before the 2021 budget process on the status of tax ratios. The purpose of the motion is to request information on the current systems in place regarding different property classes, including the relationship between the Commercial Tax and Residential Tax Rates. We need to rethink our model in order to make sure that corporate entities pay appropriately, and that smaller, independent businesses and homeowners are treated more fairly when it comes to property taxes.



New Constituency Office Update:

As of March 2, 2020, our Constituency Office is now located at 2350 Finch Avenue West, Unit C. I will be sharing further updates shortly. Look out for my Spring Newsletter which will also include the updated hours for this new location.

What are the Legal Implications of Not Filing Taxes after One Year?

All resident corporations (except tax-exempt Crown corporations, Hutterite colonies and registered charities) must file a T2 income tax return for every tax year, even if there is no tax payable. Non-resident corporations also must file a T2 return in certain situations. These returns must be filed no later than six months after the end of each fiscal period, failing to do so will result in penalties.

The penalties for filing your tax return late is 5% of the unpaid tax that is due on the filing deadline, with an additional 1% of this unpaid tax for each complete month that the return is late up to a maximum of 12 months. This penalty will be even larger if the government issues a demand to file the return and it had assessed a failure to file penalty on the corporation in any of the three previous tax years. In such a case, the penalty would then be 10% of unpaid tax when the return was due, plus 2% of this unpaid tax for each complete month the return is late up to a maximum of 20 months.

Importantly, these aren't the only penalties which companies may face. Additional penalties companies may be

subject to include, but are not limited to, an instalment penalty and a variety of other penalties for not reporting income, false statements or omissions, misrepresentations, non-compliance with mandatory internet filing and more. It is important for your business that you consult a tax expert and, if needed, hire a tax lawyer to ensure your company is abiding by tax requirements to which it is subject. Doing so will allow you to plan for your company's future and avoid unexpected fines and penalties which can throw off your company's business plan. That said, in practice, you may not always be able to file your taxes on time. The key is to minimize the likelihood you will receive an unexpected letter or phone call from the CRA requesting an examination of financial records. An audit is much more likely to be triggered if you have not filed your taxes for multiple years, rather than one year. Thus, if you are more than one year behind, you would benefit by filing for the least recent year(s), rather than making no progress to catch up."It's clear that our longterm partnership with Duke Height BIA has been extremely beneficial to our marketing students and the businesses



they engage with," said Karlene Case, Senior Experiential Educational Program Coordinator with the Faculty of Liberal Arts and Professional Studies.
