Canada-Ontario Job Grant

Employers can now receive **2/3** of the training costs for existing & new employees for up to a maximum of **\$10,000/person!**

Ontario signed the Canada-Ontario Job Fund (COJG) Agreement with the federal government in October 2014. This agreement recognizes Ontario's workforce as our most valuable economic asset and the impact that employer involvement in training decisions has on business performance.

The COJG is a new key source of funding for employer-driven training initiatives and a massive opportunity for Ontario employers to develop their workforce for a fraction of the cost.

What You Need to Know

- Ontario is receiving \$192 million/year for the next 6 years to support new employer-driven training initiatives.
- Employers of any size and in any industry are eligible for funding - no preference given.
- You choose the training, trainees, and training provider.
- Organizations over 50 employees can receive 2/3 of the cost of training.
- There is no limit on the number of staff that can access the training subsidy.
- Funding can be used for onboarding, succession planning, performance management, advancement and/or upgrading.
- Training costs that can be covered include tuition, training provider fees, & mandatory student fees, text books, software, training clothing, tools, equipment, disability supports, and exam fees including licensing and certification exams.
- Applications are being accepted on a first-come first-serve basis.
- Once the funding is gone, it's gone.
